APPLICATION

It is both a pleasure and a privilege to extend to you an invitation to participate in our 2010 Showcase Tournament. The type of draw will be decided after all entries are received. ***Each team is guaranteed a minimum of four games.***

Entries will be accepted by MAIL only (no telephone/fax reservations). Entries are due **October 15, 2010.**

- 1. Rules and Regulations** – the rules of the Tournament shall be as set out in the OWSA Rulebook . Any changes will be made known to the Coaches on a sheet accompanying your copy of the draw. Rules unique to each tournament will be sent to you upon receipt of your entry.
- 2. Player & Team Eligibility** – a team must present valid, current player registration cards or player registration sheet of eligibility signed and validated by their governing hockey body. A player must be registered with the team she will play with in the Showcase - no player may play for more than one team. Teams must be registered in their home governing hockey association or branch, which must be either a member of or recognized by Hockey Canada or USA Hockey.
- 3. Protest** – may be heard by the rules committee. Their decision will be final. All protests must be accompanied by a fee of \$100.00 (cash), which will be returned should the rules committee rule in favor of the protest. Protests should be made as soon as possible. Protests will not be entertained on the outcome of any FINAL championship game.
- 4. Permission to play** – each team must have a permit from its governing body.
- 5. Cancellation** – there will be no refunds to those teams who cancel out of the tournament.
- 6. Rules** – A complete list of rules will be provided before the weekend.
